Field of application

- 1.a) Not SCHED and NON-SCHED traffic
- 1.b) Not licensed JET-ACFT or JET-ACFT's according Chapter 2 und other ACFT exceeding the noise values according Chapter 3, 6, 8 or 10
- 1.c) DLA-ARR and DLA-DEP in scheduled air traffic and routine non-scheduled air traffic, according Annex 16, Chapter 3, 6, 8, 10

Exceptions of 1.a) – 1.c)

- 1.1 a) SCN as emergency and alternate aerodrome for meteorological, technical or other safety reasons
- 1.1 b) On a mission in disaster or rendering medical assistance and AMB-FLT
- 1.1 c) Flight checks conducted by DFS
- 1.2 Admission by the Ministerium für Wirtschaft und Arbeit des Saarlandes

Exceptions of 1.b)

- 1.3 Flights, conducted with ACFT according. Annex 16, Chapter 3, regularly from/to SCN and only in justified exceptional cases with other ACFT (max. 10% of the flights during a flight plan period)
