Temporary reduction of capacity for summer flight plan season 2022 – application of Local Rule concerning CoVID19 FRA / request for slot adjustments for August - October 2022 (Phase 3)

Dear Madam/Sir,

As already communicated with letter from 04 March 2022 and 28 April 2022, for the summer flight plan period 2022 (SFP2022) Fraport AG still expects a reduced performance in particular for terminal procedures due to ongoing, heterogeneous CoVID-19 related restrictions, being subject to short-term modifications.

Related to the application of the Local Guideline, and to contribute to a more stable operational performance, for the total SFP2022 a capacity goal has been agreed, which lies about 5-10% below the determined coordination parameters for FRA airport.

The continued need for such reduced capacity goals also in den months of August, September and October 2022 (Phase 3) has been discussed and agreed in the Coordination Committee Frankfurt on 14 June 2022 and 22 June 2022. With the now upcoming implementation of this capacity goal also in the months of August, September and October (Phase 3) the number of planned total flight movements is to be limited to:

From 01 August to 31 August:

94 (+2) movements per hour, number of **arrivals and departures** respectively in the morning **54 arrival and 54 departures** respectively per hour and in the afternoon **56 arrivals** and **56 departures** respectively per hour

96 (+2) movements per hour, number of arrivals and departures respectively in the morning 55 arrival and 55 departures respectively per hour and in the afternoon 57 arrivals and 57 departures respectively per hour.

It was agreed that there will be no initially compulsory withdrawal of already allocated slots to reach the new capacity goals; the application of the Local Guideline is based on the principle of voluntariness. The airline can decide which flights to cancel or to retime to meet the temporary airport capacity mentioned above.

The procedure and timeline for Phase 3 can be taken from the table below:

Therefore, for **Phase 3** air carriers will be requested by Airport Coordination Germany (Fluko Flughafenkoordination Deutschland – "Fluko"), to return, in the period from **27 June to 01 July 2022**, slots and/or make slot changes for the period from 01 August to 29 October 2022, as far as slots, including rotation-related slots, had been allocated to the respective air carriers in the below time frames.

In the case of slot changes the slot availability is accessible under e-Airportslots-aero. From **04 July to 07 July 2022** Fluko will coordinate these requests, based on the new applicable capacity goals and, at the latest at 15 July 2022, will inform air carriers and Fraport on the results.

The Coordination Committee has agreed that flight cancellations or retimings of slots due to above described temporary new capacity goals, based on the application of the Local Guideline CoVID19 FRA, will be exempted from the 80/20 rule as long as such cancellations and retimings lie within the frame of the difference between the previous coordination parameters and the reduced capacity goals. Furthermore, it was agreed that in the case that air carriers make more slot adjustments than necessary to reach the new capacity goals, the requested slots will be treated / taken into account analogously to the traffic shares of the respective air carriers ("pro rata").

This approach thus continues to meet the requirements of the current recommendation of WWACG ("Conditions to grant FM/JNUS in case of temporary capacity reduction") on the basis of which JNUS/"Force Majeure" is to be granted by airport coordinators on both sides of the route.
