Temporary reduction of target capacity for the winter scheduling season 2022/23 - Application of Local Rule CoVID19 FRA Call for slot adjustments for November to December 2022 (Phase 1) and the whole season

Dear Sir or Madam.

Also due to the reduced capacity target parameters based on the Local Rule CoVID19 FRA, stable operations have been and will be achieved at Frankfurt Airport in the current summer flight plan season. In order to continue this stable level of operations in the coming winter flight plan season and even to expand it, a sudden increase in peak loads must be avoided by all means. This is the prerequisite for the return of the overall system to its former performance level - all stakeholders should be enabled to continue to build up the necessary resources.

For these reasons, Fraport AG has applied for the application of the Local Rule CoVID19 FRA also for the winter flight plan season 2022/23 (WFP2022/23) at the Federal Ministry for Digital and Transport (BMDV) in the FRA Coordination Committee on 21 September 2022.

In connection with the application of the Local Rule, Fraport AG has requested as a consequence and as a contribution to securing a more stable operational performance to set capacity targets for the application of the Local Rule limited for the entire WFP2022/23, which in the period from 06:00 - 21:59 (local time) are initially approx. 15% below the set coordination parameters for Frankfurt Airport, and then gradually ramp up towards the set parameters on a monthly basis over the course of WFP2022/23.

The continuing need to apply these reduced target capacities throughout WFP2022/23 was discussed in the Frankfurt Coordination Committee on 21 September 2022 and agreed with all relevant stakeholders in order to ensure the regular coordination parameters until SFP2023 by ramping up the target capacities accordingly in

WFP2022/23 and to avoid ad hoc reductions in the winter season. There was also agreement in the coordination committee to write to all airlines asking them to contribute to the necessary schedule adjustments to stabilise the overall system for the benefit of all

WFP2022/23 will be divided into 2 phases in which the reductions can take place:

	Phase 1 (November / December 2022)	Phase 2 (January – March 2023)

In order to ensure feasibility for the start of the winter flight plan season 2022/23 by 31 December, the deadline for applications by the airline for slot adjustment has been set at 30.09.2022. The implementation period for slot adjustments by Fluko Flughafenkoordination Deutschland GmbH ("Fluko") ends on 07.10.2022.

With the now upcoming **implementation of this capacity target in the months of November and December** (Phase 1), the number of planned total aircraft movements shall be limited as follows:

29 October to 31 December 2022:

90 (+2) movements per hour, number of arrivals or departures in the morning 52 arrivals or 52 departures and in the afternoon 54 arrivals or 54 departures per hour, number of departures after 21:00 50 departures per hour.

The applicable target capacities for Phase I (29.10.-31.12.), which are to be achieved through slot adjustments by the airlines, are shown in the table below:

Airlines are therefore urged by Fluko to return slots and/or make slot changes in the period up to 30.09.2022 for the period 29.10. - 31.12.2022 as well as for slot series in WFP2022/23, provided that slots are coordinated for the respective airline in the following time ranges, including rotation-related slots. As before, it is up to the airlines to decide which flights should be cancelled or rescheduled in order to achieve the capacity parameters. In case of slot changes, slot availability can be checked on e-Airportslots.aero.

In case the slots are outside the mentioned time periods, no action is necessary.

It was agreed in the Coordination Committee that flight cancellations or time adjustments of slots due to the described temporary new target capacities caused by the application of the Local Rule CoVID19 FRA would be excluded by the airport coordinator from the calculation of the 80/20 rule, provided that these are within the scope of the difference between the previous coordination parameters and the reduced capacity targets. In addition, there was agreement that in the case of more flight plan adjustments submitted by the airlines than are necessary to achieve the new target capacities, the requested slots will be taken into account analogously to the traffic shares of the respective airlines ("pro rata").

The procedure thus continues to meet the requirements of the current WWACG recommendation ("Conditions to grant FM/JNUS in case of temporary capacity reduction"), on the basis of which JNUS/"Force Majeure" is to be granted by the airport coordinators at both ends of the route.

Notification on the call for adjustments under Phase 2 will be issued by separate letter after discussion and consultation with the Coordination Committee at its next meeting on 25.11.2022.
