Temporary reduction of target capacity for the 2023 summer scheduling season - Call for Slot Adjustments Phase II of SFP2023 (July-September 2023)

Dear Sir or Madam,

As already announced in our letter in mid-February 2023, we would like to inform you about the temporary reduction of target capacities on the basis of the Local Guideline ReKap SFP2023 and the gradual return to the regular capacity parameters in the course of the summer scheduling season ("ramp-up") within the framework of Phase II (July to the end of September). With this letter, we call upon you to make the corresponding flight schedule adjustments and slot changes/returns for the summer scheduling season 2023 for the period July to the end of September 2023.

We would like to expressly thank you for the voluntary slot changes/returns made so far, as your support has enabled us to achieve the defined target capacities since the beginning of SFP2023, including the rehabilitation of Runway Northwest. The low operational performance in the past winter scheduling season could be improved by the measures of the Local Guideline and adherence to the target capacities in the summer scheduling season so far.

The goal is now to gradually return to the previously available capacity and the set capacity parameters for Frankfurt Airport in the rest of the 2023 summer scheduling season, as soon as the overall system and the resources of all system partners can again handle this load. By making the necessary flight schedule adjustments in Phase II, you are making a contribution to further relieving the overall system for the benefit of all and enabling further stabilisation.

In detail, it was agreed for SFP2023 in the Frankfurt Coordination Committee that subsequent target capacities for stabilising the overall system will be defined, especially

Slot adjustments in the relevant periods will be made according to the following schedule:

In order to ensure feasibility at the beginning of SFP2023, the deadline for applications by the airline for slot adjustments in Phase II was set until 02.06.2023. The implementation period for slot adjustments by Fluko Flughafenkoordination Deutschland GmbH ("Fluko") ends on 09.06.2023.

With the now upcoming implementation of these reduced capacity targets in the months from July to the end of September 2023, the number of planned total aircraft movements is to be limited as follows:

In detail, the following target capacities result in phase II:

01 July until 31 July 2023:

96 (+2) movements per hour, number of arrivals or departures 55 arrivals or 55 departures in the morning and 57 arrivals or 57 departures per hour in the afternoon, 56 arrivals or 52 departures per hour after 21:00

Airlines are urged to return slots and/or make slot changes to Fluko by 02.06.2023 for the period 01 July 2023 to 30 September 2023, provided that slots are coordinated for the respective airline in the following time ranges, including rotation-related slots. It is up to the airlines to decide which flights should be cancelled or retimed in order to achieve the capacity values. In case of slot changes, slot availability can be checked on e-Airportslots.aero.

If the slots are outside the specified time periods, no action is necessary.

It was agreed in the Coordination Committee that flight cancellations or retiming of slots due to the described temporary new target capacities caused by the application of the Local Guideline ReKap SFP2023 will be excluded from the calculation of the 80/20 rule by the airport coordinator, provided that these are within the scope of the difference between the previous coordination parameters and the reduced capacity targets. In addition, there was agreement that in the case of more flight plan adjustments submitted by the airlines than are necessary to achieve the new target capacities, the requested slots will be taken into account analogously to the traffic shares of the respective airlines ("pro rata").

The procedure thus continues to meet the requirements of the current WWACG recommendation ("Conditions to grant FM/JNUS in case of temporary capacity reduction"), on the basis of which JNUS/"Force Majeure" should be granted by the airport coordinators at both ends of the route.

The procedure agreed in the Coordination Committee on 8 February 2023 will enable a return to the previously available capacity and the set capacity parameters for Frankfurt Airport in the course of the summer scheduling season as soon as the overall system and the resources of all system partners can again cope with this load. In doing so, a sudden leap in load is avoided by the presented ramp-up plan.

The discussion of the adjustments in the context of phase 2 will take place in the Special Coordination Committee on 21 June 2023.
