Pre-announcement runway closure in 2024 and a slot restriction (PPR) due to an apron construction work

Dear Sir or Madam,

during the upcoming years, we will conduct further reconstruction work and implement EASA regulations. In 2024 the runway will be closed for nine nights in total.

We ensure you that we planned all necessary construction measures in the scope of the reconstruction with regard to a minimum of constraint to air traffic and by paying attention to the public and school holidays in Bavaria as well as the adjacent German Federal States.

The following measures will be conducted in 2024:

- → Partial reconstruction of the runway surface
- → Electrical work
- ➔ Implementation of EASA regulations
- → Apron reconstruction

We will arrange for publications of dates with operating restrictions and runway night closures in 2024:

- → as supplement IFR / VFR in the AIP Germany (Aeronautical Information Publication),
 → as NOTAM,
- → via the flight plan coordinator of the Federal Republic of Germany for the period of the night closures (coordination ban)

additionally to this letter.

From 01.03.2024 until 26.07.2023 we will reconstruct an apron which will reduce our capacity of available aircraft stands.

We will ensure a safe and organized airport operation at all time, but we need to implement some PPR rules for the construction work.

- → PPR at night time 20:00Z 04:00Z (22:00 06:00L)
- PPR for GAT (exception for homebased aircraft)
- → PPR for helicopters (exception for homebased rescue helicopters)

Especially at the peak nights, we expect a lack of parking positions and we may need to reschedule some flights.

Therefore we would like to ask you to coordinate the flights for summer 2024 as fast and reliable as possible, because we will grant the PPRs with the "**first-come-first-serve**" rule.

Furthermore Airport Nuremberg cannot be used as a planned **alternate** airport from 01.03. 2024 until 26.07 2024. Emergencies and requests on short notice due to special reasons are possible.

We will keep you informed about the PPR rules especially for the night time. Please contact us personally or at the slot conference at Dubai, if we can support you. We are highly endeavor to find a solution.

In the annex you will find a detailed chart which restriction will take place at which time.

Concerning construction periods, resulting restrictions and measures to be carried out in 2025, we will provide you with detailed information in form of a written pre-announcement in due time.
