Pre-announcement runway closure in 2026

Dear Sir or Madam,

During the past summer season in 2025, further reconstruction work was executed on our runway and the adjacent taxiway areas.

During the upcoming years, we will also conduct further reconstruction works and implement EASA regulations. In 2026 the runway will be closed for eight nights in total.

We ensure you that we planned all necessary construction measures in the scope of the reconstruction with regard to a minimum of constraint to air traffic and by paying attention to the public and school holidays in Bavaria as well as the adjacent German Federal States.

The following measures will be conducted in 2026:

- Partial reconstruction of the runway surface
- Electrical work
- Implementation of EASA regulations
- Markings on apron and runway

- via the flight plan coordinator of the Federal Republic of Germany for the period of the night closures (coordination ban)

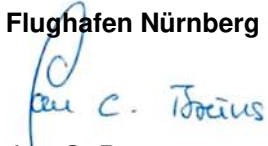
